1	Is it necessary to deliver the Declaration of Conformity or other documents?	<p>Explained.</p> <p>The selected supplier will be obliged to meet the conditions of the contract, the binding model of which is part of the tender documentation.</p> <p>The contracting authority states in paragraph 2.4 of Annex No. 2 to the tender documentation that the goods must fully comply with legal regulations and technical standards applicable to them in the Czech Republic, regardless of the originator of such regulation, including applicable EU law. How this condition will be documented by the supplier is up to the supplier.</p> <p>It is not necessary for the supplier to attach a declaration of conformity to each product supplied at the same time, but he must be able to demonstrate that he complies with the relevant regulations if requested to do so.</p>
2	Must the device cover meet some specifications, certifications with respect to the material used or shape?	<p>Explained.</p> <p>The contracting authority states in paragraph 1.3 of Annex No. 1 to the tender documentation that the quality of the images and the service life of the cameras must not be adversely affected by the effects of shocks and vibrations caused by the normal operation of the vehicle. How this condition will be documented by the supplier is up to the supplier.</p>
3	Must the device holder meet some specifications, certification with respect to the material used	Explained, the previously explained requirements amended.

ID	Question	Explanation
	or shape?	The contracting entity stipulates that a non-invasive procedure must be used for mounting on the dashboard or windscreen of the vehicle, ie it is not possible to drill or otherwise mechanically interfere with the vehicle to use the holder. Gluing the holder is permissible. The contracting authority has no other requirements for the holder.
4	Must all fasteners be delivered for solid mounting with the holder connection to the dashboard? If so, the contracting authority must specify the exact installation location and required connection to the dashboard.	In the event that the supplier decides to offer a solution consisting in gluing the holder, he is obliged to supply the goods with the appropriate amount of glue and aids for its application. See also the answer to question 3.
5	Must all necessary tools (screwdriver, key, etc.) supplied with the holder for convenient installation if standard fasteners will be used?	No. Please see the response to questions No. 3 and 4.
6	Is there a weight limit for the whole system?	Explained. The contracting authority does not set any weight restrictions for the subject of the public contract. However, the contracting authority points out that goods must be delivered that will enable the purpose of this public contract to be fulfilled.
7	The E-ZAK system wrote me that additional questions were submitted late, but they may be by law submitted no later than 3 working days before the end of the selection procedure. Is this an E-ZAK error?	Explained. The E-ZAK system correctly evaluated the deadline for submitting the request for explanation of the tender documentation, see Section 98 (3) in connection with Section 98 (1a) of the Act.

In connection with changes in the tender documentation which, in the opinion of the contracting authority may allow more participants to tender, the contracting authority extends the deadline for submission of tenders until 8 June 2020 until 12:00 (noon).
